## Organisation and provision of studies in KTU in 2021-2022 spring semester

## Form of classes:

- Academic classes are held in a contact way. In exceptional cases, they can be performed remotely, in a virtual space.
- Exercises, laboratory work and consultation seminars are held in a contact way.
- Settlements shall be made by contact, except for interim settlements, which in exceptional cases shall be made at a distance.
- Public defenses of final thesis are held in contact way.
- Students must participate in both contact and distance learning activities in accordance with the principles of the **Code of Academic Ethics** and the **Student Ethics and Behavior Study Process**.

Please do not assemble before lectures and assessments and follow the COVID-19 prevention measures set by the Government of the Republic of Lithuania: wear protective face masks, disinfect hands, maintain a safe 2 meters distance.

## Other important information:

- Students participating in **contact activities** must fit one of the criteria for participation in contact activities established by the **Government of the Republic of Lithuania** and inform the **faculty** where they are studying about their compliance.
- A student who has been **diagnosed with COVID-19** (coronavirus infection) or who has been in contact with a patient, or is suspected of having COVID-19, or has returned or arrived from certain foreign countries, must isolate himself / herself in accordance with the procedure established by the Ministry of Health and inform your **faculty study center** by email or phone.
- In case of illness or self-isolation, the student must submit a request in his / her Academic Information System (AIS) for the justification of the missed academic sessions and assessment and attach documents confirming the self-isolation. This could be a message from the National Public Health Center or an extract confirming a positive result for COVID-19 (coronavirus infection). It is recommended to fill information in AIS at the beginning of the self-isolation in order to ensure the smooth running of further processes. Please contact the study center of your faculty regarding the organization of studies in another way or rescheduling. Each situation is handled individually.
- Submission of an application to **AIS**: AIS> Studies> Submission of applications> Justification of missed classes> Regarding the justification of missed academic classes and reports.
- During the period of self-isolation, if a student does not have COVID-19, he or she must study independently in consultation with faculty remotely. If a student has been in contact with a person with COVID-19 during the activities of the University and the student has been notified by the responsible University employee, the student must leave the University premises immediately. A student may not enter the University until the end of the period of self-isolation or until the National Public Health Center confirms in writing that the student may be exempted from self-isolation.
- Exceptions apply only to foreign students who, due to certain circumstances (visa procedures, etc.), are unable to come to study by contact. Conditions are created for these students until the end of the 8th week of the 2021-2022 spring semester to study remotely, independently, in consultation with lecturers remotely.

We kindly remind you that every member of the KTU academic community is responsible for their own health and the health of others. We can only control the pandemic by working together. Thank you for your understanding.
